

# Bodzin Gallery Exhibition Application

## Now accepting proposals for 2017–2018

The Bodzin Art Gallery is accepting exhibition proposals for our 2017–2018 season. Artists at all stages of their careers, working in all media are encouraged to apply. Individual artists, or groups of two to four artists are welcome to submit proposals. Artwork may be ready-to-hang, or 3D works no larger than 2’W/2’H/1’D to be displayed in glass showcases. Applications are accepted on a rolling basis and will be reviewed by the JCCNV art selection committee.

### Submission Criteria

- All proposed exhibitions should celebrate and explore themes reflective of the Jewish Community Center of Northern Virginia’s mission: *to build Jewish connection, community and peoplehood through meaningful opportunities for every individual to explore the boundless potential of Jewish life.*
- Applications will be considered for proposed exhibitions and other future Bodzin Art Gallery shows
- Only completed applications will be considered and shall include this form, the fee, and:
  - Exhibit proposal (2 pages max.)
  - Artist statement (250 words max.)
  - Curriculum Vitae
  - 5-10 high resolution Jpeg images of your work, related to your proposal
- Due to the volume of applicants, only artists whose work is selected will be contacted
- Selected artworks must be delivered (and unsold artworks picked up) at the JCCNV, at the artists’ expense, on dates mutually agreed upon by the artist(s) and the J’s Cultural Arts staff
- Artworks must be labeled with: name, title, year, media, dimensions, price/NFS (not for sale)
- Participation includes permission for the JCCNV to photograph any of the entries for publicity or educational purposes and the photographs will remain property of the JCCNV
- The JCCNV processes all sales, retaining 30% and sending a check for 70% to the artist
